# **Duties and key result areas:**

- 1. To undertake Safe and Well-Being Visits across Northumberland, in accordance with Community Safety Department (CSD) policy and procedures.
- 2. To support the CSD Delivery Manager in developing and sustaining working partnerships to deliver the Safe and Well-Being Programme.
- 3. To support the work of appropriate personnel and external agencies to develop, implement and review the Safe and Well-Being Programme
- 4. To assist Area Teams in the delivery of community safety initiatives through the provision of support and training in community safety to Emergency Response personnel.
- 5. To work alongside and in partnership with individuals and families using a range of interpersonal and communication skills.
- 6. To work in situations where there can be conflict.
- 7. To network and liaise with other professionals and external organisations to provide services to individuals, families and carers and to challenge and question when necessary in the best interests of the user.
- 8. To process appropriate referrals; provide/seek advice and information as appropriate and refer appropriately to other agencies.
- 9. To promote multi-agency working and communication.
- 10 To ensure that all work carried out is accurately recorded, as required by Service and Community Safety Department policies and procedures.
- 11. To carry out periodic testing and maintenance of Community Safety Department equipment and Personal Protective Equipment, and complete maintenance records kept in accordance with fire and rescue service procedures.
- 12. Support measures to ensure that the health, safety and well-being of customers of the Community Safety Department are maintained in accordance with Service and NCC policies.
- 13. To attend conferences, working groups and other forums as required at local and regional national levels.
- 14. To establish and maintain appropriate working relationships with individual service users, groups, families and staff of other agencies.
- 15. To be aware of and implement adult and children safeguarding policies and procedures and directly undertake work in this area; e.g. attending safeguarding strategy meetings.
- 16. To assist the team in meeting deadlines in submitting research for the Multi-Agency Safeguarding Hub (MASH).
- 17. To make case recordings and provide reports in accordance with statutory and agency requirements. To use information technology as appropriate.
- 18. Other duties appropriate to the nature, level and grade of the post
