Control of the servery</li> <li>• Managing and contributing to the washing up, setting up and clearing away equipment and tables</li> <li>• Managing and contributing to the cleaning of the kitchen, surrounding area and equipment.</li> <li>• Managing and contributing to the receipt and safe storage of goods, stock control, stocktaking and completion of monitoring sheets reporting any discrepancies to the immediate line manager</li> <li>• Managing the administration, collection, reconciliation and security of monies relating to the service including till operation and cashless operation. Contribute to the catering provision at special event as required.</li> <li>• Responsible for the security of the kitchen.</li> <li>• Managing all staff in the kitchen including the recruitment, selection, training, appraisal and other related activities.</li> <li>• Ensure equipment is fit for purpose and properly maintained.</li> <li>• Assisting with the operation of vending services where necessary.</li> <li>• Work to achieve set financial and business development targets, ensuring that the kitchen resources are used effectively and efficiently at all times.
